Team Entry Option	No Team Entry Option this year. Only Individual/Relay option available.
Pole Vault	Special Note on PV Entries: Any individual vault entries are \$8 per entry.
Individual/Relay Entry Option	Unlimited Individual & Relay entries. Individual entry fees are \$6 per individual and \$20 per Relay. ENTRY DEADLINE (on directathletics.com): Monday, March 5 at 11:59 a.m.
Contract Due Date	To secure a spot, Contracts are required to by March 6th (unless/until the field is full)
Total Cost	Individual/Additional fees will be calculated as of Monday, March 6 at 11:59 a.m. Each team will owe what is reflected at that time and fees are due (with school check) when arriving on Saturday for the meet.
Claimed Spots	If an entered athlete becomes unavailable, simply "sub in" for that athlete since you are required to pay for that "spot" as of noon, March 6. Subs must be on your "active" roster.
Late Entries	Any entries submitted after 11:59 a.m. on Monday, March 6 and before Friday, March 10 at 2:30 p.m. will cost \$7 for Individual and \$24 for any Relay.

Opening heights: PV 7-6 (Girls) and 10-0 (Boys) HJ 5-4 (Boys) then 4-4 (Girls)

Minimum measure: LJ 13-0 (Girls) and 17-0 (Boys) Shot 38-0 (Boys) then 28-0 (Girls)

Please note that the LJ board is 12 feet from the sand.
