Entry Information

- The FCP qualifier meets are not all-comers meets. Entry requests that fall significantly below the accepted field for an event will not be accepted.
- Entries open Monday, 2/16 at 8:00am and close Sunday, 3/1 at 2:00pm on Direct Athletics.

- Individual event entry fee is \$10 per event. Please note that is per event, not per athlete.
- Relay team entry fee is \$40 per relay team entered.
- Entry fees are to be paid by check when you arrive at the facility, or mailed to:

Access

- All teams will access FCP on the south side (closest to Fall Creek Parkway and 38th St intersection). Doors will open at 5:00pm for teams. No parents are permitted access on the south end. If parents are driving athletes to the facility, the parents need to access the facility on the north side.
- Spectators will access FCP on the north side of the building. Doors open at 5:30pm.
- Student photographers/videographers will not be permitted in competition areas at any time.

Seating

- Teams are asked to use the seating on the back stretch and the seating around the south turn. Just know that the lower seats near the pole vault and long jump pits will have spectators.
- The home stretch seating is reserved for spectators. Teams are asked not to set up camps on the home stretch side.

Athlete Flow

- The qualifier meets are run the same as the Hoosier State Relays.
 - o All events will report to clerking. An official will escort each flight/heat to the competition area. Clerking is in the southeast corner near the start of the home stretch.
 - o Athletes do not report directly to event areas. Failure to check-in correctly can result in a scratch.
 - o Athletes that do not report to clerking will be scratched and will not be re-seeded into the meet.
 - o All athletes need to be checked-in no later than 15 minutes prior to their event start.
 - o Once checked-in, if an athlete is not in the first flight/heat, the clerks will tell the athlete when they need to be back for staging for their event.
 - o Meets that the hurdles are contested; an official will bring all hurdlers and one coach per team onto the 60m track for specific hurdle warm-up at 5:35pm. Hurdle specific warm-up will end at 5:55pm.
- Once teams arrive, they may get on the competition oval and flat track for general warm-ups. At 5:30pm, all competition areas are closed. Field event areas are not open for warm-up until an official opens the area.
- Coaches are not permitted on the track or in competition areas after 5:30pm. Coaches will be limited to the outside of the oval for the jumps and behind the ring/barriers for the throws.
